Statutory Provisions Under Maharashtra Fire Prevention and Life Safety Measures Act, 2006

01. Under Section3 of "Maharashtra Fire Prevention and Life Safety Measures Act, 2006"

(here in after referred to as "said Act"). The applicant (developer, owner, occupier by What ever name called) shall comply with all the Fire and Life Safety measure sad herring to National Building Code of India, 2005 and as amended from time to time failing which it shall be treated as violation of the said Act.

02. It is presumed that you have completed the work adhering to the provisions under section-3 Of the said Act.

03. Under sub-section (3) of Section 3, it is responsibility of the Owner or the Occupier as the case may be , shall furnish to The Chief Fire Officer or nominated officer Certificate in a prescribed format twice a year in the month of January & July regarding maintenance office prevention and life safety measure in good repair and efficient condition as specified in sub-section (1).

04. Under **sub section (4) of section 3**, no person shall tamper with , alter ,remove or cause any injury or damage to any fire prevention and life safety equipment installed in any such building or part thereof or in sight any other person to do so .

The Fire Fighting System provided by you in the premises as per Provisional No-Objection Certificate shall be well maintained & shall be kept in tip-top working condition at all the time. If the fire protection system is not maintained, retrenched then "N.O.C." will stand cancelled without any notice & you will be solely responsible to loss of life property if any, which may please be noted.

The condition mentioned in "Provisional No-Objection Certificate" will remain un changed.
